Dave:

All of the outstanding work has been completed except the following:

- 1. Dartnall on ramp to RHVP EB- Extend solid lane marking. "Cat's eyes" were installed in this location. If we are proceeding with the line extension, the reflectors will have to be removed and pavement repaired- the cat's eyes may be better, I would suggest we leave them as is. Change in alignment (same section as above)- will need to be completed along with re-surfacing. Requires additional asphalt and re-striping to correct road alignment.
- 2. Mud St. Interchange- re-striping to a one lane off ramp requires a change to the overhead sign and an updated marking drawing. The drawing will be completed by the end of 2015 and the work will be completed in coordination with the opening of the Upper RHVP (Summer 2016). Chevrons are oversized and additional curve warning signs were added L + R hand signs, a curve warning sign that better reflects the curve condition and a slippery when wet sign. All signs have been upgraded to High Intensity sheeting.

Dynamic Speed signs- all of our signs are being used at other locations. We would need to purchase one specifically for this location. Also, with all the additional signage on this ramp- it may not add value and only add to the sign "clutter" placing greater demand on the driver.

I think we've covered all of the recommendations contained in the report that we can at this point. The remaining items will be addressed once the URHVP is completed (summer 2016) and re-surfacing of this segment occurs.
